### **Mission Elder-Elect Examination | Pastor Will Wilson with Leslie Strangfeld**

- Leslie was asked to describe her faith journey and highlight sections from the Book of Order and the Book of Confessions that are particularly meaningful to her, as they relate to her mission elder elect role. Session approved sustaining the examination of Leslie Strangfeld
- for the role of mission elder.

### **Discussion Items | Finance, AN&SG, Clerk of Session**

#### *Finance*

There was a significant amount of discussion and session action related to budget for 2026, adjustments to giving for 2025, and a gift from a donor and how to apply it.

FPC received a gift of \$100k from a generous donor. \$97k will be applied to Pillars and Pathways, with the remaining \$3k used toward the Christmas offering for staff bonuses, according to the

donor's request. We are allowed to pull a maximum of 20% from the endowment fund, every 2 years. Proposing to pull some funds out of the endowment for Building and Grounds, and some to fund the new music director position.

Pastor Will asked that the minutes reflect his, and the sessions', gratitude for the gift, which will be used to pay down the current parking lot loan and allow us to retire it much sooner than previously planned.

Session approved using a portion of the endowment fund for seed for 2026 salary/benefits for the new music director and to apply a Pillars and Pathways match for building and grounds, assuming approval by the endowment fund trustees.

Session approved changing the terms of the current parking lot loan end date to extend for one year, from June 2027 to June 2028, reducing monthly payments to \$1400. The loan will be paid off in June 2028.

- Note: This provides the ability for the Pillars and Pathway campaign to cover loan payments with future recurring contributions. Extend loan to June 2028 when the P&P campaign ends. It also removes the balloon payment in June of 2027 and pays off loan in 2.5 years, freeing up \$22,000 GF budget per year. Reduces overall interest payments by \$35,000+.

Session approved, for 2025, to direct 10% of actual pledged income to mission giving. The mission tithe of 10% for 2026 will also be applied to actual pledged income. 20% of the resulting mission giving will be directed to student mission.

For the 2026 Presbyterian members' dues (per capita), the payment to the Presbytery will be based on 200 active members.

Session approved the summary 2026 budget presented on 12/16/2025, assuming a general fund carryover of \$44,000 or more. If the carryover is less than \$44,000, session agrees to make further adjustments to make up for the difference.

Session members were asked to review the 2026 budget and, if items were not needed until Q3 or Q4, to adjust expenses to late in the year to help with cash flow.

#### *Adult Nurture and Spiritual Growth*

Need to select 2 current elders to serve on the 2026 nominating committee. Session selected Ryan Horst and Leslie Strangfeld. Lolly Lawrence will follow up with deacons. Note: Elders ending

terms in 2026 are Emily Bauer, Barb Cash, Krista Wallace and Jim Fitzgerald. Deacons ending terms in 2026 are David Good, Sharon Mikkelsen, and Beth Mueller.

#### *Clerk of Session*

Need to determine the date for the January-February congregational meeting, with an eye to when budget can be completed. Session selected February 1 and agreed to change the date of the January session meeting to January 6.

#### **Adult Nurture & Spiritual Formation | Elder Jim Fitzgerald**

- FPC Adult Advent Study (“Mary - mother of Jesus”) is being led by Pastor Will through 12/21. Study is averaging 25 people through two weeks.

#### **Building and Grounds | Elder Ryan Horst**
